#### Rules to follow

1. It is the responsibility of all Coaches of Academy/Club to teach / aware the rules of **Changing Club** to the athletes/parents/guardians.
2. Parents /Guardians/Athlete are unawareness of it.
3. It is duty of Club / Academy Coach to teach the athlete/parent /guardian to bring the NOC from the Club.
4. Supply the NOC Application form to desired athlete/parent/guardian who wants to change the club for any reason.
5. Parent / Guardian/Athlete should maintain the decorum with Coaches.
6. Harassment towards Athlete by the Coaches shall not be tolerated at any level leads to the disciplinary action.
7. *The Coaches / Head of Academy cannot refuse to issue NOC to the Athletes who want to change the Club.*
8. *The Athlete should clear all the formalities before changing the Club.*
9. *Without clearance of NOC, Athletes cannot participate from other Clubs in any events conducted /organized under CLUB, DTA & STA.*
10. There should not be any kind of chaos among Coaches due to Athlete who changes the Academy.
11. **No Coaches / Head of Academy cannot accept any athlete without NOC.**
